MONTHLY REPORT TO EASTFIELD TOWN COUNCIL.

27 MAY 2024

8 MAY. I ATTENDED A MEMBER'S SEMINAR ALONG WITH THE WASTE HARMONISATION TASK AND FINISH GROUP MEETING AT COUNTY HALL NORTHALLERTON.

9 MAY. I ATTENDED THE EASTFIELD RESIDENTS' ASSOCIATION MEETING.

10 MAY. A VIRTUAL SCARBOROUGH AND WHITBY AREA CONSTITUENCY COMMITTEE WAS HELD OF WHICH I TOOK PART ON BEHALF OF EASTFIELD RESIDENTS.

13 MAY. I CONDUCTED MY MONTHLY COUNCILLOR'S SURGERY AT WESTWAY OPEN ARMS, AND AS USUAL HAD A FEW RESIDENTS ATTENDING WITH VARIOUS COMPLAINTS AND CONCERNS WHICH I AM EITHER STILL DEALING WITH OR HAVE ALREADY DEALT WITH.

14 MAY. I ATTENDED THE VETERANS SOCIAL GATHERING AT 120 WESTWAY IN EASTFIELD.

15 MAY. I ATTENDED THE AGM OF NORTH YORKSHIRE COUNCIL AT COUNTY HALL NORTHALLERTON.

I RAISED THE FOLLOWING QUESTIONS TO OUR EXECUTIVE MEMBERS.

1. THE NORTH YORKSHIRE MAYORAL RESULTS FOR THE SCARBOROUGH AND WHITBY ELECTORAL DIVISIONS.
2. THE TOTAL COST OF THE REDUNDANCY PACKAGES TO NORTH YORKSHIRE TAXPAYERS LEADING UP TO THE UNITARY AUTHORITY 1 APRIL 2023.
3. THE SOCIAL HOUSING REGULATOR IS TO BE WELCOMED. BUT IT IS DISAPPOINTING THAT THE HOUSING ASSOCIATIONS ARE SEEMINGLY NOT SELF REGULATING, IS THIS THE CASE ?
4. COULD I ASK IF THERE IS ANY REASON WHY NYC CANNOT HAVE WILDFLOWER VERGES LIKE ROTHERHAM AT A SAVING TO THEM BECAUSE OF MOWING COSTS OF £25,000.
5. SCHOOL CHILDREN PLACED IN SCHOOLS OUTSIDE THEIR OWN CATCHMENT AREA IS FINANCIALLY PENALISING PARENTS, THIS IS JUST NOT ACCEPTABLE. MORE SECONDARY SCHOOLS ARE REQUIRED ESPECIALLY A NEW ONE FOR EASTFIELD.
6. HEALTHY CHILD . ONLY 3 VISITS FROM HEALTH VISITORS FROM PREGNANCY TO SCHOOL IN NORTH YORKSHIRE, YET 11 VISITS IN SCOTLAND, JUST WHY IS THIS THE CASE.
7. WHAT IS THE CASELOAD FOR HEALTH VISITORS IN THE EASTFIELD AREA AND WHAT IS THE AVERAGE CASE LOAD FOR HEALTH VISITORS IN NORTH YORKSHIRE.
