1 OCTOBER. I ATTENDED THE VETERANS SOCIAL GATHERING AT 120 WESTWAY EASTFIELD.

2 OCTOBER, I TOOK PART IN THE MEMBERS VIRTUAL SEMINAR WHICH COVERERED THE FOLLOWING:

FUTURE WASTE SERVICES & NEW PROCUREMENT REGULATIONS.

3 OCTOBER. I ATTENDED THE SCARBOROUGH AND WHITBY AREA CONSTITUENCY COMMITTEE IN WHITBY. IN ATTENDANCE WAS ALISON HUME MP. ITEMS ON THE AGENDA WERE AS FOLLOWS:

COASTAL PARKING ISSUES INCLUDING THE OVERNIGHT PARKING OF MOTOR CARAVANS—RECEIPT OF A PETITION AGAINST THIS PROPOSED BAN & ESK VALLEY RAILWAY—A NEW BEGINNING. I CHALLENGED ALISON HUME ON JUST WHY SHE HAD VOTED NOT TO RESTORE THE PENSIONERS WINTER FUEL ALLOWANCE.

7 OCTOBER. I CONDUCTED MY MONTHLY COUNCILLOR'S SURGERY AT THE WESTWAY OPEN ARMS IN EASTFIELD. I HAD SEVERAL RESIDENTS THAT CALLED IN TO SEE ME WITH THEIR RESPECTIVE CONCERNS AND COMPLAINTS WHICH I HAVE EITHER DEALT WITH OR AM STILL DEALING WITH.

9 OCTOBER. I ATTENDED THE BEYOND HOUSING DROP IN STRATEGY EVENT AT THE BEYOND HOUSING HEAD OFFICE IN BROOK SQUARE SCARBOROUGH.

10 OCTOBER. I ATTENDED THE VIRTUAL SCARBOROUGH AND WHITBY AREA CONSTITUENCY MONTHLY BRIEFING.

15 OCTOBER. I ATTENDED THE NYC EXECUTIVE MEETING AND RAISED MY VERY REAL CONCERNS ABOUT THE 2,500 FAMILIES IN THE SCARBOROUGH AREA ALONE WHO ARE DESPERATE FOR A SOCIAL HOUSING / COUNCIL HOUSE HOME. MORE HAS GOT TO BE UNDERTAKEN TO GET THESE PEOPLE A PERMANENT HOME. THERE WAS A PROPOSAL FOR SOME 11 NEW BUILD TEMPORARY HOMES TO BE PURCHASED FROM THE DEVELOPER KEEPMOAT ON THE MIDDLE DEEPDALE DEVELOPMENT IN EASTFIELD AND WILL ALLOCATED TO FAMILIES WHO ARE EITHER HOMELESS OR THREATENED WITH HOMELESSNESS AND ARE EITHER CURRENTLY IN SUCH ACCOMODATION OR FOR FAMILIES IN PRIORITY NEED. I SUPPORT THIS INITIATIVE 100%. THESE HOMES WILL BE IN SMALL CLUSTERS OF TWO

OR THREE HOMES ON THE NEW DEVELOPMENT. I SINCERELY HOPE THAT THESE FAMILIES WILL BE WELCOMED WITH OPEN ARMS.

22 OCTOBER. I ATTENDED AN HIGHWAY AREA OFFICERS/ MEMBERS SESSION AT THE TOWN HALL SCARBOROUGH.
